Please arrive on the starting day by latest 2.00 p.m. Please do not arrive on the previous day. You will have to remain in the Academy until the completion of the course, which ends on the finish day (as given above) at 7 a. m.

You will appreciate, that the courses are going full and normally we have a waiting list at Dhamma Giri being the main Vipassana Centre. Hence we sincerely wish that you attend the course. In case, for some reason, you are unable to attend please inform us at any time even within seven days prior to the course by phone, email, or fax (stating your confirmation no.), so that we can accommodate another student.

Please bring the following items in addition to other personal items of daily use.

1. Original Govt. photo identity card preferably Aadhar Card and one photo copy of it.
2. A recent passport sized photograph
3. Bedsheets-blankets
4. Torch/Alarm Clock/Lock
5. Mosquito-repellant/ cream, if required by you
6. Umbrella/ Raincoat in the monsoon season (June to October) and sweater and shawl in the winter (November to February)
7. If you are on medication, please bring enough stock of all the medicines which you require during the course.
8. Passport and visa documents in case of all non-Indians. Non-Indians also need to bring a passport sized photo.

NOTE : Laundry service will be available at the Academy during the course.

You should have gone through the Code of Discipline of the course carefully. You are required to abide by the same very scrupulously, most important of which are :

- To remain in the Academy till the course ends, even if difficulties arise during the course
- To maintain complete silence from the beginning of the course up to the breaking of silence on Day-10 of the course
- To set aside all other meditation practices, rites, rituals, recitations and prayers during the course
- To maintain complete segregation of sexes while in the Academy
- To abstain from use of any type of intoxicants during the entire course
- Students who come to the course intoxicated (drugs or alcohol) will not be admitted in the course.
- Pregnant women will be admitted in the course only from 4 upto 7 month of pregnancy.
- Dress should be simple, modest, and comfortable. Tight, transparent, revealing, or otherwise striking clothing (such as shorts, short skirts, tights and leggings, sleeveless or skimpy tops) should not be worn.




